Current policy amended by adding the following sentence as the third paragraph: Any staff member who learns that a student is pregnant or is informed of such by the pregnant student will promptly inform the school nurse.

2. BEDG Minutes

Current Goffstown BEDG revised as follows:

Paragraph #3 ~ remove 3 III and replace with RSA 91-A:3. Add reference to regulation BEDG-R. Under legal references: please list RSAs in correct numerical order (A:2, A:3, A:4)

Lorry Cloutier moved Policy BEDG to the Board for a 1st read as amended, seconded by Fred Hayes. Vote: 4-0-0 – All in Favor – Motion Passed

It was determined as part of the review of the RSAs associated with BEDG and BEDG-R, that all minutes are to include a DRAFT watermark until they are approved at the following meeting of the subcommitte and/or the Board.
